DG ELARG – 8th February 2013 Media Evaluation Summary Report

Summary

Brussels has set progression in the normalisation of relations between Pristina and Belgrade as a condition for the granting of an opening date of Serbia's accession negotiations to the EU, but it was reported by Vecer (SL, 7/2) that President Nikolić had said "the last thing that I would do, for as long as I live, would be to agree to or accept Kosovo as an independent state" adding "if the Kosovo President Atifete Jahjaga insists on Kosovo's independence, the Belgrade-Pristina dialogue will not be moving in the right direction" (focus-fen.net, BG, 7/2).

The foreign ministers of Croatia and Slovenia Vesna Pusiç and Karl Erjavec announced on Wednesday that they had found a solution to the issue of Ljubljanska Bank (dnevnik.bg, BG, 7/6). After more than six hours the two ministers agreed on a solution, but did not discuss it. Erjavec is likely to persuade Parliament to a two-thirds majority required for ratification of the Accession Treaty of Croatia according to Delo (SI, 7/2). Pusiç said that the solution "brought no harm to anyone but benefitted both sides" (Dnevnik, SI, 7/2).

Greek daily Eleftherotypia (7/2) reported that Turkish Prime Minister Erdoğan again stated that his country is looking for alternatives as they can no longer wait for the EU to accept them and that the Commission's unit for Turkey, the Office of Commissioner Štefan Füle, MEPs and veteran diplomats in the team of EU High Representative, Catherine Ashton, are watching the developments on this issue with concern. According to Phileleftheros, (CY, 7/2) however, unfortunately, they are not wondering whether they should blame themselves for the current impasse, together with Ankara and EU member states. Commissioner Füle said that the Commission is monitoring the compliance demonstrated by Turkey in respecting human rights and is helping it implement the relevant reforms.


The former Chancellor published research showing the 15 countries that have joined the EU since 1995 had to wait on average nearly a decade after submitting their initial applications. The Better Together research showed the length of time for new countries to join the EU has varied from three years for Finland to 14 years for Cyprus.
